**Our small businesses are the lifeblood of our economy but Congress constantly undermines us at every turn. If Congress would stop crushing our innovation and creativity and entrepreneurial spirit, then together we can build a strong and thriving Main Street that will create jobs and restart the engine of our economy.**

**DeFranco Delivers Idea #1: Tax breaks for Small Businesses.**

**My first idea is a solution that will have a tremendously positive impact on jobs and our economy by unlocking the potential of small business and Main Street.**

We have an unfair and illogical tax code. Here is the massive problem with the tax code: A small business that makes \$100,000 is paying essentially the same tax rate as a business making \$10 million, and a business of \$335,000 is in the exact same tax bracket as a \$10 million business. This is a HUGE problem. A business at the lower level has very different needs and far fewer resources than one that generates 100 times more revenue.

**Any person in the real world would see that this set up is unfair, illogical and bad for small business. Why hasn't my opponent done something about it?**

**My solution: Lower Taxes on Small Businesses = Fuel Job Growth & Grow Main Street.**

1. Lower the business tax rate from an actual current rate of 34% to 26% for small businesses earning between \$335,000 and \$1 million.
2. Lower the rate from current actual rate of 34% to 29% for small businesses earning between \$1 million and \$5 million.
3. Lower the rate from the current actual rate of 34% to 32% for small businesses earning between \$5 million and \$10 million.
